- 2. Springwater Town Supervisor Babbit Henery met with My Tech, Co., Casey Janke on October 8, 2024 at the Town Park to discuss placement and requirements for the new camera system. Anticipates similar number of cameras & system in use at town hall w/remote monitoring capabilities.

NEW Business

- 1. Livingston County approved rate increase for the Snow & Ice Control on County Roads. The County went from a five-year contract to a three-year contract increasing the rates in \$100 dollar increments each year, October 15, 2024-October 14, 2025 rate of \$4,900.00 per centerline mile, October 15, 2025-October 14, 2026, \$5,000.00 per centerline mile, and October 15, 2026 -October 14, 2027, \$5,000.00 per centerline mile.
- 2. A discussion with the Town Board Members from a letter received from MIRABITO, regarding the Town of Springwater using 100% kerosene vs fuel oil 7 fuel oil blend. The Board agreed they did not want to make the change to the 100% kerosene vs fuel oil blend.

3. A discussion with the Town Board Members on the Application for Water Service for property on 8106 S. Main Street. The property owner would have to put the service in or hire it to be done.

1. The Livingston County Water Authority is anticipating taking over the Wastewater Treatment Facility (WWTF) by January 1, 2025.

Board Reports

Town Clerk - Shared information with the Springwater Board on donating Thanksgiving meals to the "Open Door Mission". Supervisor Babbitt Henry to check to see if flag money was donated to the Springwater American Legion this past spring.

Councilman Proctor (Recreation, Town Clerk, Planning) – Discussion with Board members on bringing back the Legion softball tournament to benefit the Vincent house to the Town Park

Councilman Canute (Water) - Absent

Councilman Gnau (Sewer) – Deputy Supervisor Gnau stated Livingston County Water Authority needs to clean up at the sewer plant before takeover is completed. The County has no use for the Bulk water system. Councilmember Gnau suggested to the Town Board keeping the bulk water system for the Town, updates would be needed by the Town to make usable.

Councilman Mason (Fire; Highway) – Councilmember Mason was unable to get onto the Empire Access Website to sign up for internet service. Supervisor Babbitt will let the County know the website is not working properly. Councilmember Mason, asked the board members thoughts on bringing GEO eashing Geocaching treasure hunt to the Town of Springwater. The Board supported the idea.
